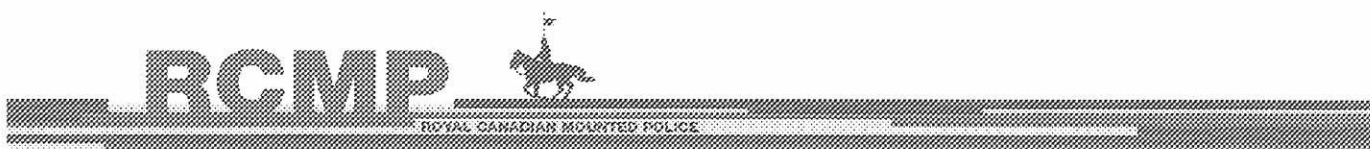

BACKGROUND:

2013-06-20 the RCMP were called upon to respond to local state of emergency orders in numerous communities and to ensure traffic safety on regional roads impacted as a result of severe flooding in Southern and Central Alberta.

STATUS UPDATE:

High River - Another 300 homes are expected to be re-occupied today, which will largely complete Phase 1 of the staged re-entry plan. Phase 2 is expected to start 2013-07-01 and will see most businesses re-occupied and homes in Sector 2 re-occupied. The returning of firearms began this afternoon. Two individuals received their firearms and two others requested the RCMP temporarily hold on to them. A press release to local and regional media was used to advise residents of the return process.

Bus tours of High River by residents to be completed today. The return of vehicles will begin on 2013-07-01.

There are 11 State of Local Emergencies still declared in the province being: City of Calgary (Renewed), Town of Black Diamond (Renewed), MD of Ranchland (County-wide cancelled - Now only for Dutch Creek Watershed, Oldman Watershed and Livingstone River Watershed), MD of Foothills (Renewed), City of Medicine Hat (Renewed), Siksika Nation (Renewed), Town of Turner Valley, Tsuu T'ina Nation, Stoney Nation.

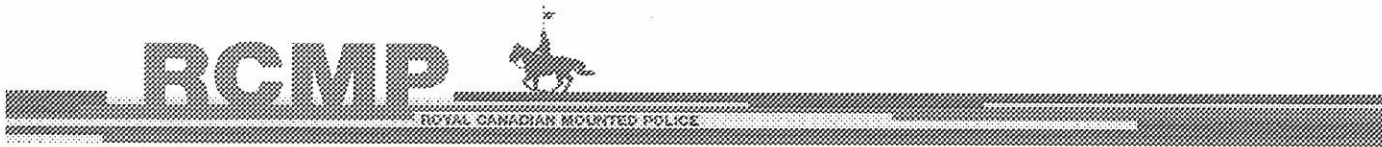
A Provincial State of Emergency remains in effect for the Town of High River.

Siksika Nation: Power has been restored to the entire First Nation.

RCMP accommodation: A temporary Camp for members deployed to High River is being established near High River with 70 beds currently available.

Phase two and three of the Camp construction is on schedule to be completed by 2013-07-01 bringing the total

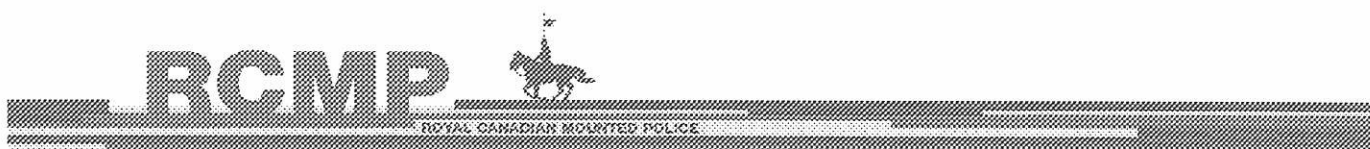

Hi Janice. I expect this issue will likely come up tomorrow at "prayers" so I wanted to send you this info now so you'll have it in the morning.

The total number of firearms secured during the search and rescue is 529. We have secured additional firearms during the provincial home inspections bringing the total to 553. The ones secured during the home inspections were from residences where the home owners are not likely to return in the next couple of days.

We have returned firearms to a total of 5 people. In fact there is a gentleman at the Det right now picking up 93.

We have signs posted at the evac centres advising people they can come and pick them up and we physically went to 15 residences in Zone 1 which is open and no one was home.

As far as the initial number of 2000 that was conveyed to you, the Commissioner and PS late last week, clearly this number was inaccurate and I accept full responsibility for this inaccuracy. When the request for the number went out through channels to High River Det, I don't think the person on the receiving end knew or realized the importance of the "ask" and likely just guessed. Totally not acceptable and I will pursue this at another time on several levels but I do believe we were in the middle of the "battle" at the time. And while I was "unhappy" when I found out the real number later on Friday, I guess I do understand why this happened.

Let me know if you think you'll need anything else for tomorrow and feel free to share this with anyone you feel appropriate.

As of this moment, K Division employees continue to provide assistance to the residents of High River as a result of the recent floods in southern Alberta. Undoubtedly, you are aware that significant critical media attention has been focused on the RCMP's response in High River, in particular the seizure and temporary storage of unsecured firearms, which were left behind as flood waters rose.

Despite our best efforts, to publicly communicate the circumstances surrounding our actions in High River, there was a mounting criticism and skepticism in some quarters as to the propriety of our response.

Yesterday, the Commissioner, while expressing pride in the Force's response in High River acknowledged this growing criticism and consequently asked the Commission for Public Complaints against the RCMP to look into the circumstances giving rise to our actions. 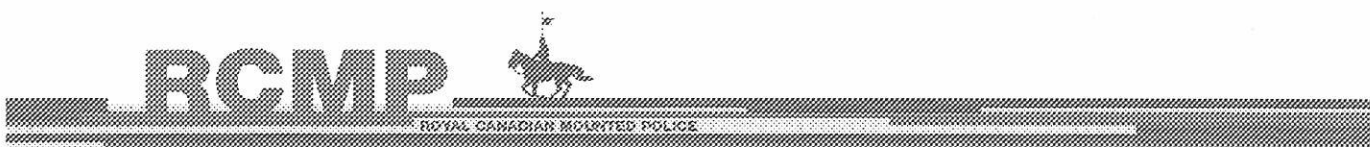

- for your information, I'd like to provide some information with respect to the authorities and legal justification the members of the RCMP were operating under in High River during the search and rescue phase of this flooding.

By way of background, on Thursday June 20th, the heavy rain and fast flowing water through the town of High River resulted in an emergency evacuation for all residents of the town of High River. As first responders, the RCMP immediately engaged in the coordination and evacuation of as many of the residents as possible under some very challenging and dangerous weather and flooding conditions. Due to the very fast flowing water and rising water levels, many of the residents were not able to leave their homes through normal exits and were forced to retreat to higher areas of their homes including their roof tops. Despite efforts to rescue stranded people with boats and other marine assets, the boat rescue operation also had to be suspended due to the fast flowing rivers of water and large floating debris (garden sheds, vehicles, picnic tables) in the streets of the town. Rescue efforts quickly turned to a request for air assets to assist in the rescue of residents from their roof tops and to that end, a local private helicopter company out of Red Deer was quickly contacted and deployed to High River. In addition, a call for assistance to the Canadian military was made for the deployment of SAR helicopters to hoist people from the roof tops of their homes and businesses. During the course of the air rescue, 600 rescue missions were performed by both the private helicopter company and the CF resources.

On Friday June 21st, the rescue mission by the RCMP turned to efforts to locate people who had been stranded inside their homes from the previous day and were unable to escape due to a physical disability, age, or perhaps being pinned or barricaded by items inside the homes. Based on the premise that police are subject to a common law duty to protect life and the exigent circumstances which existed at the time of this flooding disaster, RCMP officers entered private residences in High River to search for occupants who may be at risk or harm without a search warrant. During these residential searches, several people (28) were indeed found stranded in their homes and were subsequently rescued.

Seizures in Plain View

While we were engaged in these residential searches for stranded occupants, we came across situations where firearms had been left unsecured inside the home. We cannot, legally, ignore this and must seize them and make them secure until they can be returned to their owner. We recognize people left in a mad rush, and as such may well not have had time to secure their firearms, so we are not interested in pursuing those types of charges.

If other items were seized under the plain view doctrine, such as illegal drugs, an assessment would have been made as to whether grounds existed to obtain a Search Warrant to search for additional evidence and whether there was time permitting. To my knowledge, no additional search warrants were pursued.

I am also aware of the provisions of the Emergency Management Act and we have obtained a legal opinion from our counsel through the DOJ as to how and when we should consider the provisions of this Act. It is my understanding that authority from the Minister should be obtained if homes are to be inspected for any health or structural issues. The opinion from DOJ with respect to our actions in general is that given the chaotic evacuation of some southern Alberta towns, and the impracticality of conducting inquiries, that the RCMP have a good argument that members simply do not know whether someone is injured inside or whether there are latent dangers like ruptured fuel lines,

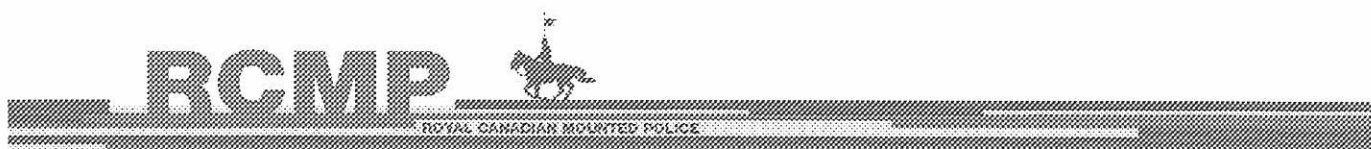

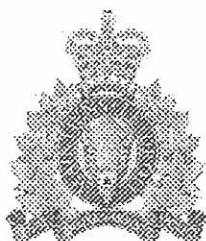

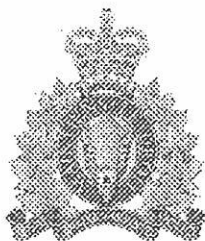

CONSIDERATIONS:

- The Canadian Firearms Program is not responsible for the seizure of firearms. This activity fell under the purview of 'K' Division in this instance.
- The articles by Gunter, Clabough and Breakenridge imply that the firearms were illegally seized. According to RCMP officials, the firearms that were seized were not safely stored and therefore in contravention of the *Storage, Display, Transportation and Handling of Firearms by Individuals Regulations* prescribed pursuant to subsection 117(h) of the *Firearms Act*. The officers may therefore have the right to seize these firearms under subsection 117.04(2) of the *Criminal Code*.

ACTIONS:

- No action required.

ISSUE: University of Toronto group fabricated a Liberator pistol using a 3D printer.

CONSIDERATIONS:

The article in question made the following claims:

The team at U of T didn't break any laws.

- In this instance, laws may have been broken should the individual who actually printed the firearm not be in possession of a valid restricted firearms licence (Matt Ratto does not). In addition, if the Liberator was made to factory specifications, it is considered a prohibited firearm. As such, only businesses with the appropriate licence would be able to print such a firearm. Without such a licence the production of the firearm would be illegal and punishable under subsection 99(1) of the Criminal Code.

Canadian law strictly prohibits the practice of making homemade guns.

- It is illegal to manufacture or possess a firearm without the appropriate licenses and applicable registrations. If, for example, law enforcement found an individual in possession of a 3D printer-manufactured firearm without appropriate licences and registration, the firearm could be seized and the individual charged.

When asked how police could stop people from printing handguns in their basement, Dr. Ratto's response was curt: "They can't."

- According to a press release by Danish company Create It REAL, the company's new software will "prevent 3D printing of guns" by recognizing not designs for specific guns, but instead specific components that would be used in the construction of the firearms.

ISSUE: Commissioner Paulson has referred to the High River, Alberta situation as a "firearms seizure" in contrast to earlier statement made by the RCMP that indicated the firearms in question were not seized but "secured".

CONSIDERATIONS:

- According to RCMP officials, the firearms that were seized were not safely stored and therefore in contravention of the Storage, Display, Transportation and Handling of Firearms by Individuals Regulations prescribed pursuant to subsection 117(h) of the Firearms Act. The officers may therefore have the right to seize these firearms under subsection 117.04(2) of the Criminal Code.
- As of July 3, 2013 the RCMP has begun returning the firearms to their owners.

ISSUE: High River Alberta Firearms seizure investigation to begin shortly. Questions remain regarding the legality of the seizure and public opinion appears to have remained polarized in editorials and letter to the editor on this issue.

CONSIDERATIONS:

- Public sentiment surrounding the seizure of firearms in the wake of the High River Alberta flood is still very polarized.
- The RCMP has confirmed that in some cases trigger locks were used for the firearms in question.
 - The class of the firearms with trigger locks that were seized was not given in the article. Restricted firearms must also be stored in a locked container so that it cannot be readily broken into.
 - Under subsection 117.04(2) of the *Criminal Code*, the peace officer must be satisfied that there are reasonable grounds to believe that it is not desirable, in the interests of the safety of the person or any other person, for the person to possess the firearm to seize it without warrant. As such, even if trigger locks were used, in this case the RCMP may still be justified due to the state of emergency in High River.
- It is unclear whether or not the RCMP requires an ATT for individuals to reclaim their firearms (note that ATTs would only be required for restricted firearms).

ACTIONS:

- No action required.

ISSUE: RCMP confirmed that secured firearms were seized while RCMP officers searched for survivors during the flooding in High River Alberta.

CONSIDERATIONS:

- The RCMP claimed only non-secured firearms were seized.
- Secured does not necessarily mean stored pursuant to the *Storage, Display, Transportation and Handling of Firearms by Individuals Regulations*.
- If the firearms in question were all non-restricted, then trigger locks are sufficient for compliance with section 5 of the *Storage, Display, Transportation and Handling of Firearms by Individuals Regulations*. However, restricted and prohibited firearms must also be locked in a container, vault or room and meet supplementary conditions under the Regulations.
- It is known that at least one prohibited firearm was seized.
- Further, the Criminal Code provides much more general authority to police.

ACTIONS:

- No action required.

Our only involvement is in relation to assisting the detachment with the destruction of flood damaged ammunition turned in to police by residents of the community. So far, about 2,800 pounds of assorted ammunition and explosive powders have been destroyed using our Mobile Ammunition Combustion Systems (MACS) and controlled burns.
