Re: COMPLAINT - RCMP ATI FILE: A-2013-05970

Please find attached a copy of my original request to the RCMP dated September 30, 2013 and a copy of the RCMP's undated no records response that I received on December 12, 2013. The RCMP's response states: "Based on the information provided, a search was conducted with the Canadian Firearms Program. Please be advised we were unable to locate any information relating to your request."

I specifically requested the search be conducted in: "OTTAWA HQ, K DIVISION, SOUTHERN ALBERTA DISTRICT & HIGH RIVER DETACHMENT "- NOT "with the Canadian Firearms Program."

We understand that Forms 5.2, Report to a Justice are required to be completed under section 489(1) of the *Criminal Code of Canada* for all items seized before they can be disposed of or returned. Also in the RCMP's response to their *Access to Information Act* file number A-2013-04354 page 38, I found this quote in one of the RCMP e-mails: "***A Report to a Justice (5.2) will be required for the firearms deemed to be stolen and / or subject to a prohibition order. S/Sgt Morton to confirm by Email once all firearms have been checked on CPIC and advise results.***"

Please ask the RCMP to conduct a more thorough search for these firearms seizure records. The residents of High River deserve a diligent search for all RCMP documents related to the unwarranted search of more than 1,900 homes and seizure of their private property.
