Dear Mr. Young:

This is in response to your request under the Access to Information Act received on May 27, 2013, worded as follows:

"Please provide copies of documents, reports and/or correspondence that list all current or active contracts and agreements entered into by the Minister, the RCMP and/or the Canada Firearms Centre related to the administration of the Firearms Act and the monitoring and enforcement of Part III of the Criminal Code of Canada. Ideally the lists of contracts and agreements would include: (1) The names of the private companies, public agencies, other Federal Departments, other governments, other countries, international organizations and Non-Governmental Organizations (NGO's) who have signed contracts or agreements; (2) The title and purpose of the contract or agreement; (3) The date the contract or agreement was signed; (4) The value of the contract or agreement."

Based on the information provided, a search for records was conducted in place. Enclosed is a copy of all the information to which you are entitled. Please note that some of the information has been exempted under Sections 14(a), 19(1) and 21(1)(d) of the Access to Information Act. Copies of these sections have been enclosed for your reference.


With regard to the application of Subsection 19(1), please note that the provisions of Subsection 19(2) have been considered and do not apply in this instance.

Please be advised that you are entitled to complain to the Information Commissioner concerning the processing of your request within sixty days of the receipt of this notice. In the event you decide to avail yourself of this right, your notice of complaint should be addressed to:
