- Hwy #22 at Elbow River - call in to Alta Transportation to close HWY #22 . Water completely across road now. Members on scene.
- RV County advises that they may evacuate the Hamlet of Bragg Creek. Power may be shut off. If thi occurs RCMP will be asked to secure empty Town . They will advise when decision has been made.
- Redwood Meadows has a Voluntary Evac order in place .
- 2 Firefighters have been swept away. Crews have them in sight and are trying to retrieve them.
- Morley has localized flooding but no one is in any danger. Morley administrators are starting up an EOC and have offered their schools as reception centers for any stranded motorists from Hwy#1.
- the flooding on Hiway #1 at OZADA is reduced . Traffic is moving there now.

Rain has stopped and water levels starting to drop, Flooding in residential areas of east Blair water levels dropping enough . Crews are dealing with log jams and debris on streets.

Hwy 3 west to Sparwood down to one lane traffic, highway still open with delays

Hwy 22 north and highway 940 north still closed .

Adequate manpower at this time.

One camp of over due camper however in a remote area that no vehicle will get into. We have contacted Forestry to see if they can check on subject with a helicopter when they are doing their fire patrols, they are busy right now, and will attempt to assist. We will attempt in the AM if not heard from, perhaps use MPP that will be down in our area in the AM . Overdue is adult male by himself staying in camper, approx 1.5 hours north of here . bridges and roads all out in the area .

was just advised by the SAD EOC that the male involved in this incident has been rescued, however, the female, who was initially located, disappeared before swift water rescue could attend. She is believed to be most likely in the water, with little chance of survival, if that is where she ended up.

1543 Sgt Brent Hawker Ft Mcleod to Insp Pott/SSgt Ness

- Flooding Southern Alberta District - Fort Macleod Detachment •
- High volumes of rain have resulted in flooding in the western part of SAD . This is effecting the Oldman River Basin from Crowsnest Pass through to Lethbridge.
- Situation Reports will be generated in the form of BN's from each of the Commanders highlighting Current Status .
- An EOC has not been established for the Town of Fort Macleod, nor the MD of Willow Creek, however a high

water stream advisory is in effect.

- The Town of Fort Macleod has advised local residence in the low laying areas adjacent to the river, that there is a risk of flooding. Members have also visited these areas, as well as local campsites and rural locations to advise homeowners of the risk of high water. (no evacuation order has been given)
 - None of the local bridges have been closed and the current flow rate has been increase from 1700 to 2100 cubic feet of water per. The detachment has been in contact with the Town of Fort Macleod, but as yet no Local State of Emergency has been declared. The high water level is not expected until approximately 2100 hrs, and levels have risen approximately 6 inches in the past three hours.
- We have 6 members available should circumstances change, and area detachments have been notified.
- continue to liaise with the Town of Fort Macleod and attend the EOC if required.
 - Sgt. Neely MRO has been engaged.
 - We continue to await any directions that may be provided by Mayor and Council, and to notify any residence that may be effected by evacuation concerns. The flooding conditions are forecast to be greater than the 2005 flood, however less than observed in 1995.

1548 hrs Ssgt Waidson to Insp Pott email

- Update as of 1520 hrs. RV County is shutting the power off to Hamlet of Bragg Creek. They want to evacuate but they have no way to get to everyone. The debris in the water is holding up the boats. They have a call in with the DND to see what equipment they can provide to help. They will advise if they need assistance.
- There is a media release out telling people to leave Bragg Creek. 2 of those people have been knocked off of the West Bragg Bridge and are in the water. Recuse is trying to get to them.
- RV County told about release and are correcting it to advise those that are flooded to leave, those that are safe and dry to stay put.
- RV County update : DND is not available to assist with EVAC. Considering SAR to assist.
- We may need to call in some OT to secure Hamlet.
- As of 1545 Alta Transportation has still not closed Hwy #22.
- Bridge on Hwy #66 is closed. Water is eating away the foundation. Closed by barricade but not manned.

James (Jim) Cornish CONTACT # 780-427- 8643 Director, Field and Recovery Operations, Alberta Emergency Management Agency, Ministry of Municipal Affairs was requested to head down to High River to begin categorization of homes in High River to start the processes to get some people back into their residences.

Jim advises that they already have inspectors on the ground and ready to join inspection teams, however are requesting RCMP resources but were advised that all RCMP resources are tied up with the search and recovery mission, and will be for two more days. The RCMP Superintendent (name not provided) also indicated that this function could not be performed by sheriffs given the potential for violence

The requirement to have an RCMP officer is two fold 1) to show residents that the entries to the houses were supervised by a peace officer 2) Concern for safety of inspectors (belligerent refusing, illegal activities ie. grow op etc.). He advises they already have had 1 individual get violent with them.

Jim Cornish wants to start inspecting the homes right away concentrating on the Category 1 and 2 homes whereby citizens could return back. Category 3 and 4 are homes that will need to be bulldozed or are in very bad condition. Jim Cornish advises the majority of the homes will likely fall under the Category 3 and 4.

RESOURCES ASK from the RCMP:

To assist with Inspectors - 3 to 4 RCMP members starting tomorrow morning 0930 hrs after briefing and working 12 hour shifts 0800 till 2000 hrs

On two separate occasions today, RCMP led teams rescued individuals in the town of High River. The two females were discovered when RCMP led teams were conducting door to door house searches. At the time of their discovery, both women indicated that their situations were becoming quite desperate and one of the women appeared to be very distraught. One of the residents was rescued by a team in a boat while the other resident was located by a team in a light armoured vehicle. Upon being rescued, both individuals were relocated outside of the evacuation area.

In each case, the female residents had chosen to disregard the evacuation order and stayed in their own homes. An evacuation order for the town of High River had been implemented on Thursday, June 20th, 2013.

Gentlemen,

At this point I don't have a schedule for the Detachment for continuing service. I believe the issue may originate in language. High River and High River Detachment are 2 separate entities, one group is the EOC group and they have the overall security and the overall emergency operation. High River Detachment is separate to the point of being left in the dark often.

At this point I have no resources dedicated to me and the EOC is neither prepared to release 15-20 guys to me nor do they have the bodies. They steal from us at times.

Basically Detachment needs 3 - 5 man teams under an Ops NCO for each operating period. Last night I sent a message via Dianne to Wade with the BCP and a hand written org chart. It was late and I missed a point on the note. I indicated Op's NCO 1 night and 1 day, but failed to state we needed this to repeat for all operating periods. For clarity, what is needed is: Minimally, what I have put on the chart, ignore the x2 and I need everything below the Det Com repeated 3 times, one for days, one nights and one on RTO.

I am very concerned as I have been told we should have our own dedicated resources. Brent Kiebel was told last night we were to look after getting our own resources by his EOC contact. If the guys here today, most on day 5 at least, go home I will be here alone in the am.

To reiterate High River Detachment is considered a separate operating group by the EOC and it has no clear dedicated schedule or resources attached to it that I can see at this point.

I need some clarity on this before noon. I told my guys last night that they were here for at least 4-6 weeks on a 5 on 5 off rotation and other than leave only people excused by C/Supt Harrison were exempt.

On another note entirely, I would like to have HR Traffic Services transferred to my command for Admin purposes. What I am after is the ability to facilitate the guidelines of the memo you forwarded yesterday. A note from whoever their commander is to them advising they must clear return to work with me and follow my directions with regards to operations inside HR. Basically they can't go to their homes or do property checks for anyone including themselves until the reentry plan allows them to their homes. I believe Supt. Howard Eaton is the guy to talk to regarding this.
