Dear Deputy Commissioner McGowan:

During this flooding disaster in southern Alberta, I have admired the dedication and commitment of Alberta's law enforcement agencies to maintaining law and order and ensuring the safety of persons, property, and the communities. Earlier this week, I had the privilege to join the Hon. Vie Toews, Minister of Public Security through High River and he shared the same level of admiration for the terrific service from members of the RCMP.

As discussed with you yesterday, throughout my visits to High River over the past week, some residents in High River have asked why firearms were collected from numerous private dwellings. The concerns from residents revolved around three general concerns. First, I would ask you to please confirm that these firearms are stored and not confiscated or seized. Second, is there a plan to communicate to Albertans a process to retrieve their lawful property? Last, will there be a process if proof of ownership was destroyed in the flood?

Again, I thank you and the RCMP for their exceptional service at this time of crisis in southern Alberta.

Summary: CBC News reported live from High River where officials provided an update on re-entry plans.

>> Reshmi: And now to High River, Alberta, with an update on when people can return home. Let's listen in.

>> We have several hundred thousand people in reception centres now and we have 12,000 to 14,000 people from all over and cards from people displaced all over High River and it is important to us and we appreciate you reporting this so that how things are progressing and we are at day eight or day nine and sometimes it feels like it's day 89 because there has been so much that's gone on and it began with the tremendous amount of water and we all know that. A system the hikes of which we have not seen and one that dropped a tremendous amount more of water and we have a lot of data analysis to do and the initial reports indicate that once the water levels reached in many areas to 1-100 year flood that they continued to exceed that and then many of the systems started to fail so we have a lot of data analysis to catch up and we don't know if it was a 1-500 or 1-1,000 year event and more than 1-100 and exceeded it quite remarkably. That being said, the province and to the municipal counsellors and my colleagues from every department to provide resources to make sure that Albertans were kept as safe as possible and mitigated this as quickly as possible. There were almost 30 communities in Alberta and unprecedented that had various stages of the emergency and some focussing on the emergency efforts and with planning and preparation as they went forward. And no doubt that the effect on our community was very different. Some had moderate damage and are moving quickly and some with more extensive efforts and High River is the epicentre and the community with just as much house damage but no other community that had extensive infrastructure damage and when this was completed there was no water and no sour and there were no have nothing and it made it difficult to start the recovery process for (indiscernible) because you need to know how far the community has come and led by local folk and I remind you guys every time that emergencies are managed at the local level. And the people in the community have done an exceptional job of bringing services online. You have heard people comparing this to Slave Lake which was a tremendous disaster and so does the mayor and this is a disaster, not a flood, in this community. But unique challenges were the infrastructure damaged not just the bridges and roads which we know of and we had one service truck just a few days ago skillfully found another sink hole which is why we're still working very hard to make sure that we have safe and secure communities. We allow people back in. And we had a sewer gone and in this situation and this isn't just a flood and a disaster. When water comes in and it destroys things and washes out and 2/3 flying over of this community is still underwater because it is a collection bowl for the water. This means we have much more challenging infrastructure needs before we can allow people to roll back in. And it is quite remarkable actually in many places and power starting to be restored and we have done engineering assessments to find out if roads are safe in communities and health inspectors and home inspectors have been going through. And we can work on getting people back into communities. And that and Minister Frazier will speak about that shortly. We are looking at re-entering even though some of the infrastructure damage is much more significant than any other disaster we have had in this province, flooding or fire, and we are looking at being potential 50% ahead of schedule on when people are going to be allowed to re-enter. That is because of some of the incredible work of the people of the community led by the mayor. Now, you can imagine all the devastation and the damage is incredibly hard to cope with. And I know that even on the ground here has been working for 20 and many circumstances 24 hours a day for eight or nine days now to try and address the situation. And so even exhaustion can become a factor. We don't want it to become a factor in order to make sure that we address the challenges. This morning the mayor called me and asked if the province would be willing to accept the responsibility of

managing now the recovery efforts going forward because we are at such a critical junction approaching the point where people will be able to start to re-enter in a phased approach. If we would assume responsibility to make sure that and help relieve some of the fatigue by bringing in new resources and I said yes. We have an O.C. that resigned which I believe this is circulated already which has us assuming responsibility and Minister Frasier will be overseeing the recovery efforts here until such time and I don't think it will be a very long time. We have made enough progress the stress and tension level goes (indiscernible) and people feel safe and secure that high river will return to normal sooner rather than later. I want to once again praise the mayor and the municipal councillors who have done an exceptional amount of work. And now the minister will lay out the strategy going forward.

- >> Thank you. When I have seen what been happening on the ground and I want to emphasize what the mayor has been seeing in the evacuation centre and yesterday I saw a woman breast feeding her child with three kids around a cement table in the middle of the heat and I can tell you that the mayor and his council and... came here to bring the full force of the government to assist the people because when we got elected, it was for the people and to do what have right for the people and that is what we will do and if we are not doing that, then what the heck are we doing. And as we continue, we are going to think of those people and I am pleased to say that tomorrow residents will be able to re-enter their homes in a small portion of the northwest part of the city. Providing that it is safe and we will provide more detail on that in the future. This disaster, as the minister said, and the mayor and everybody recognizes, is not just your mundane flood. It is a disaster. And that extraordinary circumstance requires an extraordinary response. And that is what mayor block and council recognize and that is what they have done. They have asked the government to come in and make sure that we handle the full responsibility of this emergency moving forward. In my role, I'll be assuming all that responsibility. I'll be supported from the Alberta emergency management agency and other provincial officials and town employee. They will (indiscernible) me with all necessary plans and programs and will have the full resource of the provincial government. This afternoon we'll implement a three-phase plan to support and recover the long-term restoration of High River. Phase one is to make the town safe and begun construction of tech rare neighbourhood. Once I leave this media conference, my team and I will conduct a safety assessment of the sown and affirm the entry criteria. Following the assessment, residents will have the opportunity to tour the town on buses. Phase two begins tomorrow with a stage re-entry for some residents in the northwest corner and that is just a week after the flooding which is a testament to the amazing work we have seen from the elected officials on the ground. In Slave Lake it was 12 days and they didn't have to worry about a secure road system and is critical to focus on the health and safety reasons and where we enter the state of emergency.
- >> We will hand over responsibility and it is essential that we come together and dig deep and feigned the patience and -- and find the patience and situation and I know that you are stressed and frustrated if you are one of the evacuees of a person living in high river that is ousted out of your home by this flood. So give me your patience and we are here to work for you and the resident of High River. Thank you.
- >> I asked the government to take over emergency leadership (indiscernible) in the town of High River. It is clear that the size and scope of this disaster is beyond anything we have ever seen before in Alberta and is bigger than the destruction suffered by Slave Lake as devastating as that was. The situation is much bigger, more complex, and more difficult than our municipal council can handle. I have asked Minister Fraser to help oversee the immediate recovery and first steps to restoration and there are powers and resources the province can -- and expertise that can marshal far beyond what our council can do and we will need all that support to get the town back on the feet. The council and I will continue to play a key role in High River and handle nonemergency functions and do whatever we can to support associate Minister Fraser in ensuring the first priority which is getting all the residents home as quick as possible when safe to do so and returning life back to normal in High River.
- >> Good afternoon, everyone. I am inspector Woolsey and I am the spokesperson for the RCMP on emergency operations and I have a relatively short operational update for you this morning. And of course, as always throughout this incident, public safety remains job one for the RCMP in High River. I am pleased to report that the community remains secure overnight if RCMP has approximately between 160 to 200 RCMP officers on the ground in this community around the clock keeping it secure. We have no known breaches of the perimeter last night and that is good news. We continue to provide police officers to assist home inspection teams in keeping them safe and secure and all the parties here in facilitating the quickest return to High River as we can. I want to finally continue to thank the public and all of the citizen of High River for their patience in these trying times and operation and I was at several of the reception centre and the love and respect I felt for the RCMP was heartwarming given the circumstances those people find themselves in. I can't thank them enough. Thank you. Questions? (Question inaudible)
- >> Sure. Schreiber and I will leave cards up at front for you and so the northwest should get in tomorrow and then as we go directly south, we will work our way in a deliberate, methodical fashion from east to west and from lesser

affected to more affected areas. We think that will be about a week before we do the southern part of the city and then there is that on the west side of the highway and an issue on where the big pond is where the homes are still underwater which could take up to three to five week before we can pump it out and dry it out and have people back in there.

(Question inaudible) Sewer, water, electricity, sink holes, roads, just generally unsafe conditions and conditions that have moved back and black mold and there is a myriad of issues with all of those.

- >> You said west to east and you -- you said east to west but meant west to east.
- >> We are doing sector one tomorrow. Sector two, expecting that to be ready between three to five days depending on how quickly the assessment teams work. Three and four and five to seven days. And then sector four will probably take much longer and three to five weeks because it is still underwater. The one peninsula of land that is not covered, how long for them?
- >> We'll be more specific about the peninsula of land.
- >> Right in the corner along the highway.
- >> So here? Right here.
- >> Right above. Okay. So if we can get to those houses and if it is safe, then we may allow re-entry. But one of the problems is that this infrastructure that is supporting all those homes is, still all underwater. The homes may be above water but the power and sewer and all that stuff is underwater.
- >> How many people are going home tomorrow?
- >> First of all, again, it is an extensive process and to recognize that somebody I have called in with the expertise to help me in this process. As we go through it, it is important to remember that every house we see while it looks safe on the outside may not be safe on the inside and we need to make sure the inspectors get in there and the health inspectors make it safe and number one priority. And second time as we go through it again, we are asking for great patience because as they do the bus tour they may assume their house is safe and go through that and give us the time and start tomorrow to put people back in their homes in that quadrant and most of the homes have already been visited and there may be one or two left that need to be visited by a home or health inspector and we will get them in there and allow people later tonight to see their home and start that process whether it's grieving or getting prepared for the next stage.

(Question inaudible) this is difficult to say. It is a long weekend and people are all around the province and if they are available to come and want to get into their home, they will get into the home depending on the criteria and there are homes where people will not be able to get into but with supervision and understanding to grab personal belongings and others will be able to move right in. (Question inaudible)

>> We are tracking about 1,000 home and probably about 5,000 people. And they won't all be able to go home tomorrow because some of the homes are damaged beyond occupying. (Question inaudible) so use the analogy from my life as a paramedic. When somebody drop in the middle of the street, there is lot of people that want to help but do they have the expertise that is beneficial for the patient. We have highly skilled expertise on the ground doing the work as we speak. If the people want to help, there is people in shelters that need food and that need encouragement and that is where we can use their help the most. Give us time and we are working through this and are making great progress and will continue to do that. (Question inaudible) the bussing will work with a staged area and 1900 hours, 7:00 today, essentially we'll have a ticketed system and we'll have a certain amount of buses there to bring people in and it will go from 7:00 to 8:00 tonight with a ticketed system and run buses day until people come through and we ask again for patience and immediately in the interim in the beginning basically a person 18 years of age or older and one person per household, no children, and we'll have chaplains on the bus, security on the bus and people to help them understand if the home is devastated and walk them through the process.

(Question inaudible) So the experience that we had in Manton is you can understand the magnitude and that is another event that exemplified that. And we have many people coming and unfortunately the service system in the building was up able to handle and when we got that switch we got through the line quickly and did 7,000 cards yesterday between both processing places and in fact, today there is no line-ups in Manton and I don't believe there is any lines anywhere and I have been receiving messages as the problems and hiccups come

along and yesterday we were able to get through the lines and feed the people in the lines and water them and have them shelter for them and will continue to do that. (Question inaudible)

- >> Yes, I can speak on that. And as we speak on that, let's go back nine days ago during the initial emergency in the flooding situation. The RCMP responded and conducted a search and rescue operation in this community in which we entered every home that could safely be entered and that occurred over the course of several days. Of course of the operations naturally our officers do encounter firearms. In this case these specific circumstances. remember, there had been a flood, and people had tried to prepare to leave homes in a very orderly fashion and it appears as best we can tell from being inside the homes that some people removed firearms from secure storage and left them either with the intention of removing them from the home or putting them to higher ground where they would not be damaged or vulnerable to water and it is almost as if some of the places are frozen in time. And our instructions to officers and no different than Slave Lake to secure firearms found in plain view. (Question inaudible) we are not talking thousands. I know that number is perhaps out there. The information I have at this time is there have been several hundred firearms secured for public safety reasons by the RCMP and that is the bottom line in a case like this. We secure the firearms only for public safety reasons. In the unlikely event that we identify an illegal firearm, we will then consult with the crown prosecutors with respect to what we're going to do with those. But in the vast majority of cases and I hope all of the cases we are going to return those firearms to their lawful owners as soon as possible. And there is a plan in place and there is a plan that has been developed over time and over the past several days since this incident began that return process and there will be more communication on that in the days to come.
- >> Reporter: Why is this a routine thing and in all the RCMP briefings that I was at, never was this seizure of firearms mentioned.
- >> Over the course of the past nine days I have been asked hundreds and perhaps thousands of questions. It's never come up. And these -- the security of the firearms occurred during the normal course of RCMP operations. It is not remarkable for us. Like I said, a similar thing occurred in Slave Lake. It is part of our operations. Police officers across the province seize dozens if not hundreds of firearms in some cases monthly. (Question inaudible) I am not aware specifically of anything else that has been secured from homes. (Question inaudible) yes, we would have.
- >> Reporter: Anything else? People would like to ask now because no one assumed before. (Question inaudible)
- >> Not that I am aware of.
- >> (Question inaudible) the extremely difficult moment in time but having been in the emergency operations centre for the past eight day, today is day nine, a lot of our staff are functioning in the key roles and I can tell you fatigue is beginning to set in and just these stress that our staff are dealing with is just burdening them down and this announcement today is acknowledging that they have done a heck of a job to get us through this stage and we are ahead of schedule and it is thanks to the folks in the E.O.C. that have got us to that point and to have fresh people come in and relieve the people is a god send. Thank you.

#### (Question inaudible)

- >> the bus tours will continue day and we will make it available for all the people who want to see the homes and run them through until they are done. (Question inaudible) well, I am not going to give a definite timeline that on as we continue to go through, the numbers are difficult to track anyhow. But if it's possible to give people access, we'll give them access if the area is secured cleared (question inaudible)
- >> That's difficult to say. There is obviously less than more and that is why that area is the number one priority at this point and will systemically go through each area from the least affected to the most affected. It's very difficult as you can imagine to go inside and assess the home when they are underwater and we continue our efforts to drain the water and remove it and will continue all those efforts. (Question inaudible)
- >> There is no doubt that this is an emotional time and we will (indiscernible) and continue what they do here to move on and obviously job number one is train the water and we have will have to until we get that assessment.

(Question inaudible) again, if the house is completely unsafe and non-permitable but as I understand it, the plan is to allow people if it is in bad condition to ups the risk they may take on entering the home with the professional to grab some of the possessions without putting themselves in imminent danger and they will have to wait for the remediation process.

>> Sorry, if I can emphasize that it is important that appearances can be deceiving. The truck three days ago that fell into a zipping hole thought the road was fine. We have to make sure that the roads and homes are safe and can you imagine if someone went into a basement full of water and electrocuted themselves or a kid fell in a sink hole? It may look dry but we've got to make sure it's safe before they enter and professionals are working around the clock to do that.

(Question inaudible) I am one of the individuals in that circumstance and I went to Mexico for two weeks in January and my house was fine when I got back and as long as I can get some suits and I have been the same three shirts the last three days and rolling them over and look to my role and grateful to Minister Fraser and the mayor and council and I have been holding a telephone town hall every evening at 8:30 pushing out the government information and the official announcement and a standing offer to Minister Fraser when he has time and I will keep doing that town hall and I see my role as helping to bring the temperature down and what I have experienced as I have been traveling around to the evacuation centre. People just want to know. And I think what you are seeing is that a number of people in the past when we have had flood incidents in the town they have never been locked out completely of the community and so it's the not knowing which is creating the frustration. If people know they have a green dot or yellow dot or orange or red on the door, it will make it easier for them to plan what the next steps are because if you are green it is a totally different path for the next number of week and months and if it's red, it is a totally different path for the next months and years and the actions the government is taking today to allow people to have access to at least see what the status of the house is will go a very long way towards bringing that level of acceptance and with allowing a number of residents to in the northwest community and that is fabulous news and I commend the government on moving so guickly on that. Danielle Smith. And I am the -- I don't have my official position hat on today.

(Question inaudible) we'll be able to roll out those new details and working feverishly to make arrangements for that right now. (Question inaudible) so again, we have committed the full resources of the government and as we go through it if people need assistance, we'll provide it. (Question inaudible) and so I'll leave that question to someone else to answer that question and we have people we are working with and doing everything to dewater the area. I would dare say, though, that if your basement is full of water doesn't mean that the house is not in a position to be remediated. We know that is not the case. We know that mold can be remediated and houses can be brought back to their wholesome and so we need to get the water out first and make the assessment based on the professionals and as we require and to bring in those resource.

(Question inaudible) absolutely. We are in the final details and ready to announce that we will announce that. (Question inaudible)

- >> Obviously we want to make it as convenient as possible for people and not everybody who works in High River and also work in Calgary and other areas. And people want to be here as well. We'll work you through that, (Question inaudible) (Question inaudible)
- >> There will be details coming. We wanted to focus on this discussion today. We did announce the \$1 billion to immediately go forward and will be releasing the details of the disaster recovery program that we have operated and seen operate in other circumstances before and the 2005 floods and the slave lake situation. And will be glad to know the details to get on with remediating the homes and what the next steps are as quickly as possible.

(Question inaudible) and Shane can probably and it's a matter of whether the streets and power systems are safe and when the premier and I did a tour downtown, it looked like a war zone and was incredible the devastation and the water marks were up to here the way it washed through town and broken glass and debris and chunks of log and wood and brick wall blown right out. I know people want to assess that and the priority first is from people's homes and getting people in to businesses and many of them are more concerned about the state of the business and getting their books out than they are about their home right now. We will be working with that.

(Question inaudible) Shane just hit the ground here when Rick was positioned and I know he and the minister will be doing an assessment of the work done and new resources coming in to make sure they utilize the full extent and it will take a few hours for minister and Shane to catch up and you don't want a lot of people standing around. Summary: CBC News - Power & Politics interviewed Michelle Rempel, Parliamentary Secretary to the Minister of the Environment, Liberal MP Marc Garneau and NDP MP Linda Duncan regarding the Prime Minister's office commenting on the RCMP securing inappropriately stored firearms from homes in High River. Public Safety Minister Vic Toews was mentioned during the segment.

- >> Rosemary: Well, Stephen Harper's office is urging the RCMP to return guns that officers took from evacuated homes in High River in the wake of massive flooding. The RCMP says it's securing public safety, but the Prime Minister's office has a different take. Earlier today the Prime Minister's office issued this statement. Take a look... So is the PMO interfering in the RCMP's relief efforts or did the RCMP cross the line by seizing weapons in flood victims' homes? Joining me now from Alberta in Calgary, actually, parliamentary secretary to the minister of the environment, good to see you there, Michelle Rempel. In Edmonton, the NDP public works critic Linda Duncan. And we are just trying to connect, and I think we have him, with the liberal natural resources critic, there he is, Marc Garneau who, of course, is in Montreal. Good to see you all. Thanks for doing this on a Friday before a long weekend. Michelle Rempel, let's start with you. You've been on the grouped there, too. I appreciate your perspective -- ground. The RCMP say they had to secure firearms left in evacuated homes as a matter of public safety, but the prime minister's office, as I just showed you, suggests the RCMP should focus on more important tasks. Do you think this is an appropriate statement for the government to be making seemingly to sort of give direction to the RCMP?
- >> Well, I guess two points on that. First of all, I think what your viewers have to realize is the gravity of the situation in High River, which was the water came in hard and fast. You saw the images of people being evacuated on dump trucks. This is an exceptionally quick situation that occurred, and people tried to get their valuables on to higher ground before they had to leave. And that's my understanding on where some of these unsecured weapons came from. But that said, you know, we're also the party that has stood behind law-abiding gun owners, and certainly I think it is absolutely reasonable, more than reasonable, to expect that these people who have suffered the worst possible disaster would be reunited with their property as soon as possible. But, again, I think that the focus on this has to be ensuring that the people in High River, they need to be respected for what they're going through, and we certainly don't want to add any more stress to their lives right now.
- >> Rosemary: I guess, though, my question is more specifically to the issue of the prime minister's office suggesting what the RCMP should do. I didn't think that that's the way things worked between government and the RCMP
- >> I think it's reasonable to suggest that law-abiding gun owners who have been through a very traumatic situation should be reunited with their property. Whitehorse' heard people, you know, quite incensed with this situation, and I think that is a position that's reasonable to take.
- >> Rosemary: Okay, Linda Duncan, let's get your perspective on things. What did you think of the statement from the prime minister's office?
- >> Well, let's take us back a month ago when we had a debate in the house where the prime minister was saying that members of parliament had no right to contact the RCMP. Presumably that also applies to him. I don't envy the

situation of the enforcement officers in this scenario. Our hearts in northern Alberta goes out to southern Alberta. What the RCMP themselves I understand are saying is in some cases it was clear that firearms' owners, because they were worried that their guns might get damaged in the flood, took them out of secure storage and put them in high locations.

- >> Rosemary: Yeah.
- >> What the RCMP's obligation is, as I understand it, they're sent in to secure public safety. So they want to make sure that nobody breaks in and gets somebody's firearm. And also there is a law you have to secure a firearm. So my understanding, there is no intention of seizing anybody's firearm. They're simply stored in a safe place and it's good news hearing that people are starting to be able to go home to their homes. So it is a law that you have to secure your firearm. So if they're in the open right now, that's actually violating the law. So I think the RCMP from what I'm hearing are being very reasonable. Maybe the issue was -- I don't know how the people in High River were informed of this. Perhaps if they were told this in advance or something to calm people down.
- >> Rosemary: Marc Garneau, your perspective. And speak specifically I guess to more directly to the prime minister's comments on what the RCMP was doing. The prime minister's office's comments.
- >> Well, of course, our hearts go out to the people of High River who are going through a terrible time at this point, and it's understandable that tempers are frayed, but the PMO jumping into this, politicizing it, is totally inappropriate. This is the third time in three weeks that the PMO has missed an opportunity to keep its mouth shut. There is a serious need for some adult supervision in the PMO. What they said today was totally inappropriate. This is a local police matter that should be dealt with by the police in High River, and the prime minister's office has absolutely no business commenting on this.
- >> Rosemary: Michelle Rempel, I can see you want to respond. Go ahead.
- >> I'm so angry. I cannot believe that my colleagues would not even respect the basic rights that these people are asserting right now. You know, I agree with the comment that, you know, we want to make sure that people in that area have the utmost safety. Absolutely. But I think it is absolutely appropriate to say -- and, again, to my colleagues who perhaps have not been on the ground here and don't understand the level of stress that is happening in southern Alberta, particularly in this community, this is something that is worth saying. I don't think it's unreasonable whatsoever. I don't think that it can -- it certainly can be achieved in a safe way, but, you know, to suggest that somehow the PMO is playing politics when --
- >> They are.
- >> -- When all we're asking is that somebody who is law-abiding and has a right to property has that property returned. I think it's frankly insulting to the people of that community.
- >> But I don't think, Michelle, that anybody has said -- my understanding is there has not been any indication that there is no intention of returning those firearms.
- >> Absolutely.
- >> The officers are on the spot. When you see an offence in plain view, the officers have to take action. They're not in any way haranguing or considering that anybody down there is violating the law. What they've said is they're seeing firearms. They think they were probably put in an unsafe place to try to protect the firearm, and their obligation on behalf of the homeowners as well is to make sure that those firearms are kept safe. And so I think the issue is obviously we want those to be returned to the appropriate owner when they get close to their home, and not until then.
- >> And why would anybody -
- >> Rosemary: Marc Garneau, then Michelle Rempel.
- >> Why would anybody be suggesting they're not going to be returned? Of course they're going to be returned. The police went in there because they're responsible for safety. There may have been people who couldn't evacuate or didn't. They weren't looking for guns. They went in there because of their concern for the safety of people. [Indiscernible interjections] There were guns that were there. They decided for safety reasons because sometimes looting occurs, sometimes there's concern about the safety of some of these very valuable weapons. They went in and did what they thought was right. That is a matter that can be dealt with at the local level in High River. The prime minister's office jumping in and politicizing this is totally inappropriate.

- >> I will push back. I agree with many of the comments Ms. Duncan made. Yes, we have to be concerned about safety. Yes, these arms have to be stored safely. But it is a reasonable expectation to have them returned in a timely way. Now, to Mr. Garneau's point, to accuse us of politicizing this issue after years and years of his party working against law-abiding gun owners I think is shameful.
- >> You're getting off the topic, Michelle. You're getting off the topic.
- >> No, marc. You brought this up -- Marc -- and it is fair game to push back on that. These are our constituents, Marc, because of that. Because of the fact we stood up for them for years and years and years. And to hear that today when we say this is a reasonable expectation is politicizing it, that is wrong.
- >> Rosemary: But can I just make a point, Michelle Rempel? Regularly when the **Public Safety Minister Vic Toews** is asked about RCMP investigations, for instance, very recently when he was asked about ongoing matters regarding Jeffrey Delisle, the convicted spy, he refused to answer saying the government does not comment on RCMP operational matters. And now today we have the government seemingly commenting on operational matters in High River. You haven't it both ways. You can either not comment on what the RCMP is doing or you can comment. But I don't understand why the rules sometimes applies and then it doesn't in other cases.
- >> But you also have to compare apples to apples. Commenting on an active investigation is not the same thing as saying it is a reasonable expectation to have legally owned property returned to the people who own it. And that's the case here.
- >> Rosemary: Okay. I'm going to wrap it up. That was a lively debate, and I appreciate you all being here. Michelle Rempel, I know you're out there pitching in, helping everybody out. Thanks for making the time today.

We have done a bit of backgrounding on the PROS side of the house and on work being done. This along with the firearms stuff may be of interest for any visitors.

Today we had 119 contacts at the front counter, returned 46 firearms, received 40 for storage and 2 for destruction along with a large ammunition for destruction.

Since June 20, the day of the flood we have taken 702 files and since the 23rd we show 497. These files all need significant PROS work to manage the tasks and linking to conclude. We know there are more files as many are not linked at all yet and therefore are unsearchable. This uncountable number could be as high as 10%. The ladies have been doing a lot of research and work to find the most effective way to manage this so it is both complete and trackable.

I have had the guys keep some track of the contacts they have made around town and can tell you that overall the feedback is very good.

Matt Allen is back on the firearm project and it is in good shape. All firearms except one are accounted for and we believe that 1 was secured by the owners wife and is not accessible at this time. It has been listed on CPIC as missing just in case.

All teams accounted for. No STO members seized any guns from secured cabinets. I have enclosed an excerpt from one of the members which sums up the operating procedures we had in place.

1. inform our team lead and scribe of any unsecured firearm that was in plain sight and 2. make arrangements for someone from the High River detachment to come and seize the firearms.

We did not search for firearms and only firearms that were in the open/in plain sight were to be noted and secured. The purpose of the searches were for people and animals in distress. I know that our team did not have any tools to open a locked gun cabinet and I didn't take any guns from any cabinet locked or unlocked

Now on a side note, as it was primarily the detachment members who would attend the identified locations and seize the firearms, I cannot speak to their actions. I suppose it is possible they did, but what is clear is clear that STO was not involved in the seizure of secured firearms.

Spoke with S/Sgt. Kevin Morton. He will liaise with Insp. Stewart's group to acquire 5 resources to review all firearms seized during this evacuation. Each firearm will be subject of a CPIC check to ensure that it is not stolen property. S/Sgt. Morton confirms that a PROS entry has been created for each address that firearms were located and subsequently seized for safe keeping. When the owner presents, PROS will be searched by address given. The firearms are documented on paper 1625 Exhibit forms. All efforts will be made to ensure ownership and the owners ability to safely store prior to turning firearms over. Once returned the owner will sign the 1625 returned. This document can be scanned to PROS. It is not a requirement to add property to PROS Property screen. S/Sgt. Morton will draft a plan that outlines a consistent procedure for this process. It will be clear that no one will face charges for unsafe storage.

Firearms identified as stolen will be made subject of a new PROS file and assigned for follow up. Individuals identified as being prohibited from possession will be dealt with per existing policy. These firearms will be added to PROS Property screen and secured in the main exhibit holding locker. A Report to a Justice (5.2) will be required for the firearms deemed to be stolen and I or subject of a prohibition order.

Please let me know when I can call you to discuss how youwant to link all the PROS occurrences together.

As a trial I linked your original PROS occurrence number (2013741388). If you now query in PROS using the Fast Find occurrence search and enter this occurence number you will get results to show the few occurences I have linked so far. I did not want to go any further until speaking to you first. The original PROS occurrence that is restricted will not show up, but all the one's I link to that number will when you do that single search.

I can also generate one big Occurrence Summary Report for all the occurences and save it as a pdf for you to load into E&R III if necessary or save pdf Occurrence Summary Reports for each occurrence individually if preferred.

I will need a date range to use when pulling the data from PROS. The date when the seizure of firearms from evacuated homes began and when it finished will help identify those occurrences from other matters stemming from before the flood.

As for the seized items, it may be easier to set High River Det. up with barcoding for their exhibits and enter the items into each of the PROS occurrences as created for their seizure. The Detachment will need to manage the seized goods for some time forward and they use PROS and not E&R III. I can assist with that as well if you want to go that way and there are lots of short cuts in PROS to streamline the linking (link property seized to the address it was seized from and later to the owner once identified or the person collecting the items).

Once items are loaded into PROS a report can be generated to show each item and where it was seized from along with the movements of each item.

Please advise when you are available so we can determine how you want the information presented.




